Ltd. at a price of Php 13.00 per share, minority stockholders owning a cumulative total of 178,993,440 common shares out of 219,890,839 of all minority-owned common shares, comprising 81% of all shares owned by minority shareholders, were present or represented in the meeting. Out of such 178,993,440.00 common shares owned by minority shareholders represented in the meeting, 178,993,040 votes, or 99.99% of such shares, were cast in favor of the approval of the aforementioned item, with the stockholder owning the remaining 400 shares having abstained from voting.
